### **WATERSTONE DISCIPLINE POLICY**

The lifeguards will enforce the following:

- I. The first time a person(s) violates a rule, the person is verbally warned. The pool manager/assistant manager is notified.
  - II. The second time a person(s) violates a rule, that person must leave the pool facility for the remainder of the day. The person's name will be given to the lifeguard staff and the pool management company.
  - III. If pool rule violations continue, a Board or Pool Committee Member will notify the homeowner so that corrective action may be taken.

### **WATERSTONE POOL RULES**

1. Residents in good standing may bring up to four 4 guests per adult resident. A resident of the community must accompany all guests at all times. The pool cannot be reserved.
2. Residents must possess their family RFID fob to be admitted to the pool. No one will be admitted without their pool tag (RFID fob).
3. There will be a \$25.00 charge to replace a lost Waterstone Pool admittance fob.

4. Children age 14 and under must be accompanied by a resident adult. (Maximum 4 children per adult.)

5. The **Baby Pool** is for children 5 years of age and under. Children must be accompanied by a resident adult.

6. The **Adult Pool** (smaller pool adjacent to the baby pool) is designated is for persons 18 years and over. No children shall use the adult pool except in the instance that the Family Pool is closed, and only during open swim time (30 minutes per hour) when accompanied by a resident adult.

7. The **Family Pool** (large pool) is for all residents but primarily families and children. The **Lap Lane** is designated for lap swimming only. In the event the lap lane becomes crowded, adults have first priority.

8. Only proper swimwear is allowed. Infants and toddlers must wear swim diapers or rubber pants while in the pools, per the Indiana State Department of Health. If a fecal accident occurs, the pool will remain closed for 24 hours following cleaning.

9. A lifeguard will be on duty during pool hours daily, weather permitting. Please respect and adhere to all decisions made by the lifeguard on duty.

10. The pool will be cleared and closed at the first thunder clap and/or sight of lightning and will remain closed for 30 minutes after the last thunder clap is heard and 1 hour after the last lightning is seen.

**11. No hard toys, such as hard balls, water guns, frisbees, etc., or large floatation devices are permitted at any time.**

12. Absolutely **no** running, diving, rough play, spitting, dunking, or use of foul language will be tolerated in or around the facility.

**13. Per the Indiana State Department of Health, food is not allowed in the immediate pool area. Snacking and dining are restricted to the picnic area. Drinks must be in non-glass containers and may not be consumed in the pool itself, but are permitted on the pool deck.**

**14. Pets are not allowed in the pool facility.**

**15. Smoking is not permitted in the pool facility.**

16. The Waterstone Homeowner's Association is not responsible for lost or stolen articles, accidents, or injuries. All residents are responsible for themselves, their children, and their guests.

17. Pool hours are to be determined by Waterstone HOA Board or Pool Committee. Pool may be closed for Swim Team use or Community Events.

18. During Swim Team practice, the Adult Pool is open to adult residents and children when accompanied by residents.

19. During Swim Meets, all pools are closed to resident use.
